The Business of Private Investigation In India

ur esteemed Panwanjit S. Ahulwalia has been a member of the CII since the early 1990's. Pawan has served as President and Chairman of the Council and is presently the Regional Director in India. Pawn operates Premier Shield with head quarters in India. Premier Shield specializes in risk and security prevention and serves clients in India, South Asia, Middle East and America. Recently, Pawan provided this update on the state of private investigators in India.



The Private Investigations Industry in India has entered a very interesting phase. Some of the issues faced by Private Investigators in the Western World are not a matter of concern in India. For example, issues such as privacy and data protection laws have yet to be defined in India.

Any person can do any business in India. We are very democratic. There is no legal bar to entering the investigative/detective business. One could actually be a criminal, or engage in fraud and still establish a business offering Private Investigations to the public. All that one requires to start as a proprietor of an investigations firm is to think of a name and then create your letterhead and business card. That's not even necessary so long as you can get your mobile telephone number into the hands of prospective clients.

One could commission some people who make websites to plagiarize a website of a western competitor, and start using it to market themselves. The contents of the website may or may not be true, and it would be anyone's guess as to whether the individual is able to perform the investigative tasks that are advertised. It is the client's risk in choosing a service provider.

On the flip side, we have a number of very credible investigators in the Industry. These investigators bring years of experience to the table. However, they are not

easy to find, as some organizations take in members to increase their numbers without conducting any due diligence on the members.

The issue of lack of licensure for Private Investigators is a hot topic in India at the present time. The Government has tried to introduce legislation, but the drafting of these documents was not thoroughly prepared. It was introduced by the government in Parliament, but was shot down by the Parliamentarians as being 'Inadequate'. A group of Ministers were asked to delve further into the legislation surrounding Private Investigators. Meanwhile, three years have passed and nothing has emerged. It would appear that the legislation for Investigators was buried under heaps of paper in the Indian Parliament. Even the effort of a legitimate Indian Private Investigator's Association that was formed to lobby for the legislation was to no avail.

In India, there are 28 States and seven Union Territories. There are no territorial restrictions on the regional area for conducting business. An investigative business can be registered in any state and the Investigator can work anywhere within the Country. We can cross state boundaries at will and work in any state, since we have no license. As you can imagine, this offers a great opportunity for anyone calling themselves an investigative agency. Another fundamental that impacts our industry is that in India, we have no social security numbers. We are recognized by our name followed by the father's name (not our mothers) and the place of residence. There are other means of identification, such as a passport, a driving license, a voter ID card and a tax number, but as a population of a billion people, to find a person on the basis of a name and their date of birth is unthinkable.

How secure are you? Someone might be waiting for a chance to take everything you own!

The constant advances made by manufacturers of technology draws more and more of us into the World Wide Web every day many of which, beyond the usual anti-virus programs, have little or no other forms of security. Despite how technology has advanced there are still many of us who presume that



our wireless routers at home are secure and there are some who do not think that their router requires any type of security or encryption at all. As a consequence of this tens of thousands of people have their networks and machines hacked into every day. If there was one single thing you could do to protect your system it would be to have properly encrypted wireless access.

Understanding Encryption

The first form of commonly known encryption, WEP (Wired Equivalent Privacy), was developed in 1999 and is the oldest Wi-Fi protection standard. Unfortunately it failed to live up to its name. Basically, it uses a single repeated key, making it relatively easy to break. Nowadays WEP can be cracked in a matter of minutes. These types of routers are used in the main by residential and small business customers. And as a consequence, without the addition of further protection, are easily accessed by hackers.

To improve on the weaknesses of WEP and enhance the level of encryption, in 2003 The Wi-Fi Alliance developed WPA (Wi-Fi Protected Access). Improvements included TKIP (Temporal Key Integrity Protocol), which changes the encryption key for each data transmission and more recently AES (Advanced Encryption Standard). The choice between TKIP and AES is a choice between old and new technologies, respectively. However, WPA was a stopgap measure. At the time, the Wi-Fi Alliance was working on its 802.11i standard, released in 2004, which is commonly known as WPA2.

Confusing isn't it! My apologies if you are now bewildered or bored by all the technical jargon (you would be excused for losing interest at WEP). However what we need to understand from the foregoing is that as things stand at the moment WEP just won't do the job. WPA2 encryption should be our first choice and where possible WPA2-AES.

The Importance of Passwords

Both WPA and WPA2 offer good security. WPA is theoretically breakable, but can be secure on a practical level. With a strong password of 21 characters or more, a WPA network can withstand an attack for years. Unfortunately, most people do not use strong passwords and do not change those passwords often enough thus even with WPA encryption they could eventually end up being hacked into. In either WPA or WPA2, your password is the weakest link, so make your password as strong as is reasonably possible.



the various security settings, and ensure that they block almost all personal data from "Everyone." Tell young relatives to change their year of birth by one year when setting up Facebook. If they have already signed up, then they should hide their year of birth in their settings. This is important because it is NOT possible to change your date of birth after you set up Facebook, and Facebook should not be trusted to keep it secret. Also, tell everyone to assume that EVERYTHING they ever send by email or type into a web form is PERMANENTLY public information. Lastly, tell people to create strong

> passwords that are different for every web site and application, yet very easy to memorise. It is easy to do and very valuable. Some people have problems remembering passwords but to have a secure password does not have to be that taxing. For example an easy way is to take a word and change certain letters to numbers ensuring that the numbers look loosely like the letters you are replacing then reverse it e.g. Password becomes Pa55w0rd becomes Dr0w55ap it is also important to capitalise letters at least once in your password.

Why does my network need encryption?

You can take several easy steps to protect your identity

Of all the information identity thieves' need, the easiest to protect is your Date of Birth. Therefore I advise people to lie about their DOB to any and all who do not have a right to know. Only government, financial institutions, and employers have a right to know your true birth date. Everyone else should get a fake DOB, such as merchants, health clubs, loyalty cards, web sites, and possibly even casual friends. I suggest people pick a date they like such as Halloween, Christmas day and New Years Day, etc. Another option is to use a relative's birth date. Alternatively they could change just their year of birth a little, which enables them to lie to casual friends without jeopardising birthday celebrations with them.

Another critical Identity Theft precaution is for Facebook users to understand

Apart from the more obvious reasons such as protecting your data and identity and preventing others using up your monthly allowance set by your Internet Service Provider (ISP), what many people are unaware of is that there are a number of individuals and organisations who spend their time hacking into networks and mainframes of major governments and blue chip companies with the sole intention of destruction. In order to cover the source of origin i.e. where the hackers are located they first hack into hundreds of both private and business networks to mask their identity. Where this affects an unknowing individual and/or company is that your network would have been complicit in the "Hack" albeit unknowingly. You may still be liable legally if you did not take sufficient steps to protect and encrypt your own network. Scary I know but there have been many cases where something like this has happened and unfortunately ignorance is not seen as a defence so take steps and get advice on the best way of securing your network.

Identity Theft

In the UK, identity fraud in itself is not a crime, although profiting from it is. Experts estimate that if you become a victim of identity theft and fraud you will spend anywhere from six months to two years recovering from it. Some 6 million people in the UK claim to have been a victim of identity theft. It is estimated according to recent research that up to 18 million households in the UK regularly throw away sensitive financial documents without shredding them.

ID fraud in the UK.

Nobody knows the exact cost, but it is estimated that identity fraud costs the UK £1.7bn a year with a cost of £609.9 million a year in card fraud alone and is the fastest growing "white collar" crime in the UK. According to the BBC Money Program it is increasing at a rate of 500% year on year.

A major crime that falls under the heading of ID crime is that of credit and debit card fraud. The highest proportion of this type of fraud is "Card not present." This is where purchases are largely made via the internet. The Card-not-present fraud is where the fraudster has obtained card information such as Name on Card, Card Number, Card Expiry date and CVV Code and then used this information to make purchases where a card is not required, i.e., an internet purchase.

Fraudsters employ many types of schemes on the internet to capture a person's credit or debit card information. One of the widely used methods is where the fraudster will send emails containing secret "Key Stroke Capture" software which is activated once the unsuspecting recipient has opened the email. What then happens is that a programme will silently run capturing all of the recipient's future key strokes; the fraudster will then retrieve that data on an ongoing basis. This kind of programme is usually fairly easy to spot by looking in the "Processes" tab in the task manager window. If you are not so technically minded and would not know how open task manager then on many occasions after a 'key stroke capture' program has been running for a while you will notice the speed of your machine slowing considerably. For example when typing a sentence there can be a 3 to 10 second delay before the words typed appear on the screen. Other situations where data capture is possible would be on public

machines in places such as internet cafes and free Wi-Fi areas. Also data can be captured by shopping on insecure sites and using non-trusted/ suspicious payment engines.

The latest methods of ID theft involve:

- Calling victims pretending to be their bank or other financial institution and asking customers to confirm their personal details, passwords and security numbers.
- Targeted web phishing attacks: a criminal activity where "phishers" attempt to fraudulently acquire sensitive information, such as usernames, passwords and credit card details by masquerading as a trustworthy financial institution on the internet.
- Malicious software such as spyware which can surreptitiously collect personal information from personal computers.
- Gathering of personal details through personal information posted on the web such as on social networking sites.
- Stealing mail left in communal areas of residential properties or thrown out in the rubbish.
- Stealing personal data through stealing your belongings, i.e., wallet, purse, burglary etc.

Protect yourself!

- Be careful with your personal information. If you receive a telephone call from a credit card company, bank or retail company asking to confirm certain details about yourself decline and call them back preferably through a central switchboard. Never give out personal details or passwords.
- When destroying personal correspondence such as bank and credit card statements consider a shredder or even burning them with garden refuse. If you cannot do either then tear the papers up into very small pieces and place in the refuse bin with other waste products.
- If you move address remember to inform all of the companies that send personal information to you in the post. Always consider re-directing your post with Royal Mail. If you fail to do this people moving in might have free access to your personal details and misappropriate them.
- Always use an anti virus programme and firewall on your computer.

- Beware of unsolicited emails. Do not respond to emails that have apparently originated from your bank, an authority or company. Remember that a bank will not ask for your details via unsolicited emails.
- Do not post personal details on the internet which could collectively be used to clone your identity.
- Instruct your bank not to accept any payments abroad unless previously authorised.

How do you know if are victim to this type of fraud?

- Are you missing your regular monthly financial statements? If so they could be being redirected to a fraudster.
- Have you noticed charges to your accounts that are not yours? Remember to check all statements especially bank and credit card.
- Being contacted by a debt collection agency about outstanding payments for items or services that you have not ordered. Beware of companies contacting you unexpectedly and asking for personal information.

Take Action – Act Quickly

- Firstly, do not ignore the problem. It might not be you that has ordered some goods or opened an account but the debt falls to your name and address.
- Once blacklisted for credit it may take many years to fully recover the problem. You might have difficulties in obtaining a mortgage or other bank credit.
- When unexpectedly called, ask for a name and contact number and verify this with the organisation before calling back. They should be able to provide your customer reference number which can obtain from billing documents.
- Consider obtaining a copy of your credit report from a credit reference agency and monitor your report for discrepancies.

Police Officer To Charged With Insurance Fraud In Toronto Canada

A police officer with 18 years of experience was arrested in connection with a series of staged automobile accidents that led to fraudulent insurance claims. In April 2011, Constable Carlton Watson was charged with crimes arising from assisting in reporting fraudulent auto accidents by the Peel Regional Police Internal Affairs Bureau. He is currently suspended with pay. When local news reporters attempted to reach Constable Watson at his home, he had no comment regarding the charges. Police also arrested and charged 46-year-old Brampton resident Wayne Isaacs in connection with the investigation.

The arrests followed a noticeable increase in insurance fraud activity within the southern region of the province of Ontario, Canada. The investigation into the staged accidents was conducted by the Peel's internal affairs bureau in collaboration with the Insurance Bureau of Canada.

Investigators have uncovered increasingly complex staged-accident scenarios involving tow truck drivers, mechanics and medical clinics who take part in schemes orchestrated to cash in on insurance payouts. Drivers are often paid to crash cars and seek treatment for fake injuries at clinics that are taking part in the scam. To date, reforms such as lowering payouts for auto accidents have not reduced the amount of fraudulent claims.

Frank Thibodeau, , Vice President of Bruker Detection, is a 1979 graduate of West Point with a BS in General Engineering with a concentration in Chemistry. His military experience spanning 22 years in the US Army included operations in various contingencies while specializing in CBRNE defense located in the USA, Europe, and brief operations in the Middle East and Far East.

The threat from terrorist attacks using CBRNE weapons or cataclysmic accidents from natural or unnatural disasters causing CBRNE effects is highly probable. The proximity of nuclear plants and chemical plants to highly populated areas makes many infrastructures vulnerable after disasters. Yet most government, financial, and highly populated structures have no way of ascertaining the actual dangers. CBRNE detection technologies are fundamental to the protection of critical infrastructure. Yet most facilities have questionable outdated detectors or none at all. New construction for billion dollar facilities is occurring with little or CBRNE detection. Frank will cover the Chemical, Biological, Radiological, Nuclear, and Explosives detection options, technologies, along with benefits and possible disadvantages of general technology types.


