Emergence of women investigators

Mention the word "private eye" and the image of a man with a trench coat, hat and dark glasses will conjure in the minds of most people. When a woman announces that she is a PI, the first reaction that can be expected is a blank stare. This may be followed by an aroused curiosity if she can actually do karate chops, run and jump in her stilettos like in Charlie Angels. (And if she is anything like my size, one would be wondering how she can swing from one building to another on a tight rope without bringing down the buildings! The secret is that what you

see is all the work of media graphics in today's age of computer and cyber technology!)

There is always an air of mystery and intrigue that surrounds the notion of private investigations. The private investigations business is an interesting and fascinating industry. However, it is seldom as dramatic and sensational as the media portrays it. In fact, most private investigators men and women alike do not have any tell-tale signs obvious to the public that they are investigators. If they did, it would defeat the purpose of being a "private eye", because the nature of the job requires their identity and work to be unknown in most cases as in-

vestigations are normally supposed to be discreet.

Another assumption that people make is that investigations can only be directed by a man. When people think of investigations, the work of the police comes to mind. Private investigators are normally former police officers who have retired from the public service and conducting investigations commercially as part of their second career.

While the assumption is true particularly in Asia where the private investigations industry is still at its infant stage, there is an emergence of women investigators as the business develops. The majority of these women from Asia are wives or daughters of private investigators who have worked closely and learnt the trade from their husbands or fathers. They have been the pillars of support in managing the clients, operatives and compiling the reports.

As a private investigations business is built from scratch after the man retires from his law enforcement or military profession, he normally seeks the help of trusted persons to provide the administrative support as he builds the business. The nature of private investigations work requires strict client confidentiality so the key tasks are normally delegated to trusted persons within the firm. This trusted personal assistant is usually the wife who ends up working with him, and later the support network extends to his children once they have completed their formal education.

Private investigations is where the skills required can be best acquired and learned through hands on experience. Formal education only complements the knowledge attained through work

experience.

Skills of an Investigator

So how does a woman succeed in the male dominated PI industry in Asia? From my own observations, be it for a man or woman, the key traits required for you to succeed in the investigations business are as follows:

Passion – this is the driving quality

Passion – this is the driving quality for success in the investigations business. If you have no passion for the work that you do, you will not be motivated to work hard at it. There are no set hours for investigations. Depending on the requirements of each case, you may end up with working on weekends and the wee hours into the mornings. This is not just for those involved in surveillance work. Even for those doing desk bound tasks such as report production, there are deadlines that have to be met to comply with legal requirements. You must

want to be involved in the case. You must want to help your client. You must want to get to the bottom of the matter to uncover the facts of the case! All these "wants" require passion and self motivation to steer you to doing the work. Most women take on every task and responsibilities as their babies that they nurture, especially if they are involved in the process from the very beginning.

Aptitude – either you have a knack of being able to obtain information that you need for the case or you don't. It is an ability that comes naturally. A lot of investigations work relies on the 6th sense. You can tell when something about what you see or hear is not right. You know when you have to inquire more, or dig deeper into the matter.

Inquisitive nature - Women are known to have an inquisi-

tive nature. To put it in local context, it is common knowledge that we women are known to be "kaypoh". Due to this genetic ability, women are more observant. hey tend to read and analyse situations and their environment. And they never just accept what you say as the gospel truth. Beneath the smiles, the brains are ticking – analysing, deciphering between the lines of everything that you say and do. That is why men always say you can't win with women because they will be forever dissecting how you think, how you act, what you say. On a positive note, this need to uncover the truth is an excellent stimulus for good investigations work. Women love solving problems, puzzles and they go into great details. This maternal nature makes women natural born investigators!

Management abilities – women have a natural ability to multi-task. A woman wears many hats in her life. She may be a manager at work, but at home, she is a mother, a wife and also a daughter. She has to see that everyone's needs are met so she is used to satisfying the needs of a number of different people at the same time. Her maternal instinct gives her an innate sense of compassion and her respect is earned not by her public achievements but how she makes people feel about themselves. This is one reason why women make good investigations managers.

She is able to delegate tasks - – and they do it because they want to please her, and not just because they get paid to do it. This unique trait about women is why men can never understand why he would go out of the way for a woman even though it is not love.

Women investigators can handle a number of investigations cases simultaneously at a time without getting confused. This is the same as she would know and remember all the ingredients that go into the dishes that she cooks. And how she would remember everyone's likes

and dislikes and she will go out of her way to ensure that she cooks everyone's favourite dishes.

She has patience when dealing with difficult clients – just as she may have demanding husband, children and parents to cope with on the home front.

Diverse Nature of Investigations

Another reason why women are succeeding well in the investigations industry is the nature of investigations work.

The common perception in investigations is surveillance work. Surveillance requires long hours of video recording and photography skills which is in the male domain.

However, the face of investigations is also expanding to other areas in the corporate sector such as background checks, fraud investigations, and insurance verification. Other than surveillance, information gathering is also done through research. Research is done using databases available to the public at different offices, or through the Internet. Research is also done by interviewing people.

There is more to groundwork than surveillance. Women investigators are successful in re-



trieving information from people in interviews because witnesses or subjects are more likely to speak to them due to their non-threatening nature. Curiosity is also a woman's second nature so it is not unusual for her to ask many questions and people are more likely to talk to her.

Being detailed, there are "no stones unturned" when a

woman is doing her research and analysis in her report. She will prod, query and address all issues, making her client feel that she cares for their case – which is not an illusion that she gives but she really does care! A woman's innate nature is she likes to see everyone happy. Hence, she is always happy to ensure that her client is satisfied so she will ensure that the delivery of the client reports is to their satisfaction.

Honey trapping

Recently in Singapore, the private investigations industry

came under scrutiny on the issue of its ethics in using "honey trappers" – the use of attractive women to charm a man. Specifically the news article talks of women who are paranoid about cheating husbands and engage private investigators to put her husband to the test.

The James Bond movies are often remembered for their women - the attractive sexy women who are trained to manipulate Bond into revealing his secrets to them. Honey trapping carries a negative perception for women investigators as it projects all women investigators as mere sex objects – the forbidden fruit used by the devil to tempt Adam to commit sin.

Nothing can be further from the truth for professional

CII member proves client's innocence in "rape" case

A client just sent me a copy of his book *Return to Common Sense*, by David Dickerson. While his book primarily discusses plutocracy, e-government, and cross cultural business strategies, he titled one chapter "Guilty of Innocence" and described how a lack of police protocol ruined his political and professional career. My firm and the investigation we conducted received the author's praise in the chapter describing the ordeal.

In the summer of 2006 Mr. Dickerson, with a Ph.D from Cambridge University (U.K.) was a Maryland candidate for the U.S. Senate. In that summer he was also charged with crimes against his

much younger Latvian wife. In a bizarre twist of events where his wife was seeking medical attention for post partum depression, a medical staff thought she was reporting a rape, as did the detective who was called to the hospital. Mrs. Dickerson spoke very little English and neither the medical staff or police investigators spoke Russian. Mr. Dickerson was soon placed under arrest for rape and false imprisonment. The media did what they do and with no one to turn to or even speak to for that matter, Mrs. Dickerson went into hiding. Through contacts in Baltimore, New York, and Latvia she was located and reunited with her mother in Latvia while we focused on the criminal defense litigation.

We were able to produce evidence that the police investigator failed to follow protocol and failed to conduct a thorough investigation prior to filing charges. Other evidence <u>suggesting</u> police misconduct was also discovered. Security video tape was recovered placing Mr. Dickerson away from the alleged crime scene. With this evidence before him, the State's Attorney dropped all criminal charges. Still, Mr. Dickerson's political career was ruined, his professional career has at least suffered, and his family spent more than \$40,000 U.S. in his defense.
